Hiring for heart, training for skill

This has been another exciting year at OPARC! With your support, we have provided 900 adults with disabilities with programs and services designed to help them achieve their full potential. More than half of OPARC's participants hold full or part-time jobs, enhancing the productivity of the economic community and increasing the self-esteem of the workers.

I know the success of OPARC participants is tied to the quality of our staff and I strongly believe in equipping our employees to excel in their positions. That's why we introduced The College of Direct Support, an online training curriculum that teaches best practices through comprehensive modules developed in collaboration with the Research and Training Center on Community Living at the University of Minnesota. I'm confident this new training curriculum will improve the work we do for OPARC participants.

OPARC is also proud of our success in offering employment training and opportunities to program participants. This year, we've taken that further by launching an initiative to provide paid internships and community employment as described in The California Blueprint. We've added four Employment Specialists and three Employment Evaluators to the OPARC team. These staff members go into the community, find employment opportunities, and help OPARC participants develop the skills necessary for those jobs.

This year, we also participated in the Annenberg Foundation Alchemy Tech Pilot program. This program helps to strengthen our knowledge of technology best practices and provides critical guidance and strategic feedback on future technology projects.

Events continue to be a big success this year with OPARC's 3rd annual Turkey Bowl raising \$17,490! We also held our annual Donor Recognition event and continue to host

InfoZone meetings where families and caregivers can connect with each other and stay up-to-date on topics related to caring for adults with disabilities.

In the coming year, as OPARC looks at new ways to broaden the community activities offered to our participants, we will need your continued support. 


